About the Conference:

Learning organization coined by Peter Senge has become a buzz word. It refers to organizations that facilitate the learning of its members while continuously transforming itself. It refers to an enhanced capacity to learn, adapt and change. It is an ideal towards which organizations want to evolve in order to be able to respond to pressures from the environment. Some define it as the absorptive capacity of organizations. A learning organization exhibits five main characteristics: systems thinking, personal mastery, mental models, a shared vision, and team learning. It is commonly hailed as a prescription for organizational success in a dynamic global economy. Learning organization is both a process and an end. There is a lot of literature in learning organizations on themes like 'learning systems', on the importance of single-loop, double- and triple-loop learning, knowledge management, decision making, reinventing the organizations through interventions, organizational readiness and management of change. Some have proposed that learning organizations are initiated and developed by senior management through a top-down approach while others emphasize a 'bottom-up' or democratic approach to understanding a learning organization. Still there seems to be no consensus on the definition of a learning organization. Most authors assume that any organization that intentionally designs its structure, culture, and strategy to foster learning is a learning organization.

The present conference is aimed at understanding the impact of learning organizations beyond the rhetoric.

Paper Submission Guidelines

- Only original, unpublished work is sought. Any proposal submitted to present identical or substantially similar work already published, under review for another conference or publication will not be considered.
- Extended abstracts of at least 1000 words and not more than 2000 words including a clear indication of the purpose of research, methodology, major results, implications,

and key references should reach us latest by 30th August 2013 in Microsoft word format only.

- By submitting an abstract, the author makes a good faith commitment to present his/her paper at the conference.
- Names of the authors, their addresses (postal and email), and phone numbers should also be indicated. Each abstract should have at least three-five keywords.
- All abstracts will be peer-reviewed. Authors will be notified about the acceptance of abstracts by 30th September 2013.
- The complete paper excluding the references, charts and tables should not be more than 5000-6000 words, with font size of 12, Times New Roman and single line spacing. It should reach us latest by 15th November 2013 in Microsoft Word format only.
- All the extended abstracts will be published in a compendium with an ISBN number. Some of the selected/best papers may be considered for publication in the special issue of *Business Perspectives and Research* -ISSN 2278- 5337 (registration number MAHENG13049/13/1/2011 –TC) after due review process.
- One author can present a maximum of two papers.
- Full papers will be blind reviewed by panel of eminent experts.
- In a joint submission at least one of the co-authors should be registered for the conference.
